MEETING SUMMARY

Electricity 101's

- ICEO Secretariat provided a discussion paper which proposed interactive knowledge sessions focused on the electric grid, electricity markets, utilities and regulation, recorded by webinar, and to be posted on the website.
- ETAG members brought forth following recommendations for consideration:
 - Frame the sessions within the context of opportunity, focusing on the relevance to First Nations rather than providing general information (E.g. "So you want to build a power project", "Can you sell electricity?") and then make reference to items such as the Electrification Plan.
 - Use concrete examples to demonstrate the potential issues or consideration First Nations may find in a project, such as building a transmission grid or Run-of- River project.
 - o Discuss various areas of opportunity across the province, address West Coast capacity.
 - o Include projects from outside B.C. to identify practices supporting Indigenous participation.
 - Use resource plans as a background to inform where the energy market is headed.
 - Present on market realities of the sector with additional research but avoid duplication on readily available analysis.
 - Look at the broader legislative ecosystem on the electricity market and surrounding legislation in addition to the BC Utilities Commission or the *Utilities Commission Act*.
 - Frame the webinars with a community lens, consider their perspective on affordability and reliance, legal costs, leasing, etc. Offer solutions to capacity and cost challenges.
 - Include Demand Side Management and energy efficiency opportunities.
 - Hire a firm to support engagement and consider connecting to additional events such as the adaptation forum (Feb).
 - o Determine if First Nation Major Projects Coalition could play a role in the Electricity 101s.
 - Frame the Electricity 101s with a community perspective and include metrics which reflect the realities of rural and remote energy concerns.

General ETAG Business

- Considering BC Hydro expects to have sufficient energy and capacity until the early 2030s, ETAG members expressed importance of seeking current economic opportunities in addition to positioning First Nations for a call for new clean energy supply.
- ETAG members expressed the desire for clear roles in identifying present and future opportunities.

Decisions

- 1. Meetings will be recorded and used to create a meeting summary which will then be posted publicly after ETAG and joint leadership approval. Recording will be deleted post approved summary.
- 2. ICEO Secretariat to develop a draft framework for the 101s that reframes the information per the above comments.
 - a. Include a schedule, content list, and potential presenters.

Actions

- 1. Post written summary of ETAG Meetings.
- 2. EMLI Executive to look into opportunities for ETAG to meet with new Minister.
- 3. Develop Electricity 101 Framework and bring options forth to February meeting.
